## July Meeting Recap

Welcome: At 7:02 pm Brad Gunderson KD6SFS opened the meeting and led us in the Pledge of Allegiance. There were no visitors or first time attendees.

Minutes: As reported in the June Newsletter. Brody Johnson K7VXV approved, Ken Richter KR7KR seconded.

Treasurer's report: Larry Bell N7SND reported the current total in the account being \$2024.44. Field Day costs were \$425. Tim Nesmith KI7LVC approved, Fred Govedich KI7TPD seconded.

Repeater Report: Don Blanchard WA7GTU reported that as far as he knows everything works. He questioned if any one knew if the repeater on Black Mountain was still around after the fire that had been threatening it. Tim Nesmith KI7LVC reported that the "fire folks" said they had "saved it" (the commercial building and cabin) but no report of damage was given. The noise on 76 should be gone, the cable was moving in the wind and now it doesn't.

Q & A: Terry Lee KD7TTT:

1. Q: What is a basic tool kit needed for Amateur Radio? (opinions are like arm pits)

A: A basic tool kit should include: Needle nose pliers, diagonal cutters, wire

strippers, terminal crimper, jewelry screwdrivers, sharp knife, soldering iron, and a de-soldering kit.

2. Q: What is better soldering or crimping? A: The problem with crimping is the tip contact, but if you go up and thru the hole and then

solder, that's the best and it would be water resistant. Be careful not to over crimp. Don't crimp soldered ends.

3. Q: I have coax 2 meter running from my eaves directly to a hole in the side of my house. When it rains, I get water in my house. How can I prevent this? A: You could try and apply tape or putty around wire to seal and waterproof the hole or ... a simple solution would be to make a drip loop with a bit of extra cable just outside the wall. Another solution would be to tie a string just before the wire enters the house to direct the water down the string. If the hole is much bigger than the wire you could use foam, rags, expanding foam, metal scouring pads (steel wool) to stuff in the opening.

4. Q: When I am talking on my HF radio, my wife can hear me over the TV. What can I do? A: (Get a new wife.) (Turn off the TV.) Get a low path filter and make sure it is well grounded to reduce feedback. Don Blanchard has one for sale, Sylvia Clements has a couple for sale.

Presentation:

The purpose of an antenna is to change the signal from a radio high frequency alternating current to a wave that can be received by another antenna.

Electric current always has a magnetic current. If you reverse the electric current, the

magnetic current will also be reversed.

Many types of Antenna: Dipole, Inverted V, Fan Dipole, Trap Dipole, J-Pole, Twin lead J-Pole, Loop, Sky wire loop, Vertical loop, Yagi, Quad, 7 element, Hex beam.

Antenna tuner will help to match the signals if it is not too far off.

The presentation concluded at 8:20 pm.

## FCC Administrative Law Judge Dismisses Radio Amateur's Long-Standing License Renewal Application

A California man embroiled in a long-running license renewal proceeding has lost the next step in his fight to remain a radio amateur. In a July 9 *Order*, FCC Administrative Law Judge Richard L. Sippel terminated the decade-old license renewal application of William Crowell, W6WBJ (ex-N6AYJ), of Diamond Springs, California, upon a motion by Enforcement Bureau Chief Rosemary C. Harold. Sippel's *Order* followed Crowell's refusal to appear in Washington, DC, for a hearing to consider not just his license renewal but related enforcement issues dating back 15 years or more. "Crowell's decision not to appear at the hearing has the same practical effect as if he had initially failed, pursuant to Section 1.221(c) of the Rules, to file a written notice of appearance or otherwise signal his intent to participate in the hearing on his pending renewal application, i.e., he has waived his right to prosecute that application," Harold said in the Enforcement Bureau's June 12 motion to dismiss Crowell's license renewal application. In his *Order*, Sippel said he agreed with Harold's determination. Crowell had asserted that the FCC was obliged to hold field hearings in the city nearest to a licensee's residence, but Sippel said that was incorrect. Crowell invoked financial

hardship rules, but Sippel said those would not apply in an Amateur Radio case. Dismissal of the renewal application was "with prejudice." It has been 10 years since the FCC set Crowell's license renewal application for hearing, which was to center on whether he had violated FCC Part 97 rules in the early 2000s, in part by causing intentional interference, transmitting music, and "using indecent language," and whether he was qualified to have his renewal application granted.
